*Course outcomes/objectives (action-oriented, measurable, appropriate knowledge level, linked to evaluation methods)	<p>Suggestions:</p> <input type="checkbox"/> Use a stem such as, "At the end of the course, the student will be able to..."
	<input type="checkbox"/> List with bullets (see the " <u>active words</u> " list for support in writing learning outcomes.)
	<input type="checkbox"/> Ensure these learning objectives map to course assessments, so you can measure student success in attaining these.
